### MAJOR DRUG INVESTIGATION REAPS MULTIPLE ARRESTS

**Bedford, VA** – Sheriff Mike Brown reports, after a six month operation the Bedford County Sheriff's Office Special Drug Unit (SDU), ATF and the Virginia State Police have charged 19 people which resulted in thirty-six criminal charges. The arrests were made throughout the county and included three major prescription pill distributors.

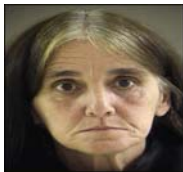
